**Town Web Page-** The board decided not to have Webs by Wagner update the web page to include responsive design due to lack of traffic to the web page. Last month there were only 32 hits to the web page.

**Dog Tags-** Tabled until Amy speaks to the county.

**Emergency Medical Service Advisory Committee Contract Renewal-** The board would like to meet with other townships regarding the contract. Jeff will contact the others to set something up.

**2018 Budget-** The budget workshop is scheduled for Oct 18 @ 6pm, budget hearing is scheduled for Nov 13<sup>th</sup>@ 7pm.

Fall Road Inspection- The fall road inspection is scheduled for September 9<sup>th</sup>

**Fire Department Budget Payment-** Currently the town gets a bill from the fire department at the end of their fiscal year which is October 1. The town then pays the FD that amount to be used the following year. It has been suggested that instead we give them a set amount based on an average of the last 10 years. Anything left over would go into a future equipment fund. The Town of Black Wolf has also feels it is a good idea.
